



BOARD OF DIRECTOR JOB DESCRIPTIONS

A complete list of job descriptions for all of the Board positions is included in the current By-Laws. The following listing is a simplified (and subjective) description of the duties of the various positions:

CHAIRMAN OF THE BOARD

· Previous year's President serving as advisor to the Board

PRESIDENT

- Oversee operation of the chapter
- Prepare a plan for the year including a complete budget that is presented to the membership at the June GM
- · Chair all GM meetings and Board meetings

INDIVIDUAL DEVELOPMENT VP

• Oversee and find chairman for all of the projects in the ID area. These projects include anything that is for the benefit of the membership (GM's, Socials, Training, Sports, etc.).

COMMUNITY DEVELOPMENT VP

 Oversee and find chairman for all of the projects in the CD area. CD projects are those that benefit the community (Scholarships, Donations, Seniors & Kids Programs, etc.).

WAYS AND MEANS VP

• Oversee and find chairman for all money making and chapter fund raising projects (Haunted House, Tree Sales, etc.).

MEMBERSHIP VP

 Create a committee to handle all recruiting and orientation projects (Call Nights, Membership Booths, New Member Socials, etc.).

SECRETARY

 Handle all mail, work with the Treasurer on the roster, take minutes at all meetings, take charge of out going Chapter correspondence (Thank You notes, Sympathy cards, etc.).

TREASURER

- Manage the chapter's finances, including handling dues billing and collection.
- Create a monthly report detailing the chapter finances.

DIRECTORS

• To help the area VP to which they are assigned and to serve on the Board and help plan chapter business.

ALL OFFICERS AND DIRECTORS SHOULD PLAN TO ATTEND ALL REGULARLY SCHEDULED GM AND BOARD MEETINGS.

The following positions, while not considered part of the Board of Directors, are very important to the running of the chapter:

MEETINGS AND PROGRAMS CHAIRMAN

- · Works within the ID area
- Plan all GM programs (except Associates Night)

PUBLICITY CHAIRMAN

- Works within the CD area.
- · Help project chairman and committees to obtain publicity
- Keep a scrapbook of news clippings for the year

WISE FOX EDITOR

- · Works within the Secretary's area
- Supervise the publication of our monthly newsletter

As I mentioned earlier, there is a much more complete description of all of the positions in our By-Laws. If a position is of interest to you, look it up in the By-Laws or speak to me or another Board member about it. You may also notice that there are several other positions listed in the By-Laws. The positions that I listed above are the ones that we are presently utilizing. Future administrations may expand the Board to include any or all of the additional positions as needed.

Being on the Board of Directors is extra work, but it is also a lot of fun. You get to be involved in the planning of all chapter business. While a VP position might not be right for a brand new member, there are plenty of other positions that would be. Don't be afraid to make the commitment. It is well worth it!!
