





Interviewing people for these articles, I am always sure to find something interesting about their hobbies, jobs or interests that make them unique. 



#### A LETTER TO THE MEMBERSHIP:

I'd like to take this opportunity to inform you that I am running for the position of President for the 1997-98 year.

The Nominations Committee has asked me to write a message to the membership about "Why I want to be President" next year. After composing a long list of reasons, I came to the conclusion that, all of you would have the same reasons written down if I asked you why you joined the Jaycees. We are all interested and want to be involved with the activities of our community. I enjoy being involved with community projects, and as this year's Vice President of Community Development, my main concern was in that area; and thanks to the support from you, our commitments to the town were met.

I am very proud of being a Foxboro Jaycee, primarily because of all the programs we give to the town, but also because of the recognition we as a Chapter get from the townspeople. There's hardly a week that goes by that there's not some mention of us in the Foxboro Reporter. I'm sure that you have experienced this feeling of pride when someone from the town acknowledges the time and effort we give to the community. One line in the creed that we recite once a month really sums up my feelings "service to humanity is the best work of life."

I feel that I have gained enough experience after being deeply involved for the past three years, to lead this organization in the coming year, and I hope that you have the confidence in me to work hard for you.

There are two important By-laws being voted on at the March G.M. - one month before elections. One of them has to do with making the Donations Director a permanent position and other giving the President an option of choosing to have a Presidential Director. I am in support of both of them. Cathy Hickey was a great help this year as the Donations Director and I believe that it is a position that needs to be added as a permanent position to the Board. We, as a chapter dealing with the amount of money that we do, need to have a committee doing research on all prospective donations. I also support the Presidential Director position as an appointed position by the President. A few years ago there were three Presidential Director positions available to the President-elect filled by "election", but essencially selected, by the President-elect as asked of the Nomination Committee. At this time one is now our Dues Director, and if the new By-law passes another will be the Donations Director. I don't see anything wrong with giving the authority to the President to choose a member who they feel is needed on his/her Board. Perhaps there is a member that wanted to be on the board and the President saw as a potential contributor on board, however, was not elected to any position. would be the President's opportunity to invite them to be one of his/her directors. At this point in our organization's existence, a presidential director, if needed would not be a trainee, but rather a person who the President believes could contribute to the new board. I believe it would be in this organization's best interest to have enough confidence in its future President to have the option to select one person to help them out as they saw fit.

I personally, sure would like the opportunity to choose <u>one</u> of the 15 people on my board, welcoming the chapter's choices for all of the other positions. Hope to see you all at the March G.M. and thanks for your support during this year.
